10. Receive & Review the Assessment Roll
 - (a) Examine the roll,
 - (b) Correct description or calculation errors,
 - (c) Add omitted property, and
 - (d) Eliminate double assessed property.
11. Discussion/Action- Certify all corrections or error under state laws (Wis. Stat. 70.43).
12. Discussion/Action- Verify with the Assessor that open book changes are included in the assessment roll.
13. Allow taxpayers to examine assessment data.
14. Review Notices of Intent to File Objection.
15. Proceed to hear objections, if any and if proper notice/waivers given, unless scheduled for another date.
16. Finalize and Approve Assessment Roll
17. Adjourn (to future date if necessary).
